The Director, NML reserves the right to accept or reject any or all or in parts of the tender document without assigning any reason.

1. Price per Tender Set is Rs.500/- (Rupees Five Hundred Only) in the form of D.D. in favour of "Pay & Accounts Officer, Safdarjung Hospital, New Delhi", payable at New Delhi. The tender documents can also be downloaded from the website <https://eprocure.gov.in/eprocure/app> or <https://nationalmedicallibrary.in> and can be submitted along with demand draft of Rs.500/- in favour of "Pay & Accounts Officer, Safdarjung Hospital, New Delhi", payable at New Delhi towards the cost of tender document. 2. All the relevant documents ensuring fulfilment of terms & conditions along with EMD must be enclosed with the technical bid.

## INSTRUCTIONS TO BIDDERS

### A. Submission of Tender Document: -

Tender is invited under Two Bid System i.e. Technical Bid (Envelope A) & Financial Bid (Envelope B) which should be as under:-

- i. **Envelope A should contain Technical Bid as per 'Annexure - B'** along with EMD of appropriate amount in the form of FDR/BG. Demand Draft of Rs.500/- towards cost of tender documents should also be enclosed along with Technical Bid in case tender documents are downloaded from the website. This sealed envelope is to be super- scribed as "Envelope- 'A' - Technical Bid"
- ii. **Envelope 'B' should contain Financial Bid as per 'Annexure-C'**. This sealed envelope is to be super- scribed as "Envelope 'B'- Financial Bid".

Both the above sealed envelopes i.e. Envelope A and Envelope B along with the prescribed covering letter (Annexure-A) are to be placed in another sealed envelope super-scribed as "Tender for subscription of MedOne Education Database under NML-ERMED consortium run by NML, New Delhi". The inner and outer envelopes shall be addressed to the following address and shall be submitted /dispatched so as to reach before the expiry date and time for submission of the Bids.

Financial Bids of only those bidders who are short listed on the basis of Technical Bid shall be opened and considered for award of contract for *subscription of MedOne Education Database*

### B. Earnest Money Deposit and Security Deposit: -

The bidder shall submit Earnest Money Deposit (EMD) of Rs.2,96,000 (Rupees two Lakhs ninety six thousand and seven hundred only) long with the tender for supply of MedOne Education Database under NML-ERMED Consortium. The EMD will be submitted in the form of FDR/Bank Guarantee (from scheduled commercial Bank) in favour of "Pay & Accounts Officer, Safdarjung Hospital, New Delhi", payable at New Delhi. *The EMD shall be valid for 225 days from the date of tender opening/extended date of opening (if any).* The EMD will not carry any interest on it. The EMD will be refunded in full on receipt of request from the unsuccessful bidders after the finalization of tender. However, in case of tenders accepted for supply of MedOne Education Database, the EMD will be refunded only after deposition of the Security Deposit by successful bidders. The Performa for Bank Guarantee for EMD is at Annexure-D

The successful bidders will be required to deposit Security amount @ 10% of the total value of the order (for MedOne Education Database) in the form of Fixed Deposit / Bank Guarantee (scheduled commercial Bank) in favour of "Pay & Accounts Officer", Safdarjung Hospital, New Delhi", payable at New Delhi. FDR/BG is to be *valid for a period of 15 months from the date of award of the contract.* The Security Deposit shall remain in the custody of "SO/DDO", NML till the supply of ordered database is completed. The Proforma for Bank Guarantee for Performance Security Deposit is at Annexure-E.

The successful bidder/Agent/Vendor will have to enter in to *an agreement on a Non Judicial stamp paper of appropriate value, the cost of which has to be borne by the bidder/Agent/ Vendor itself,* and to make necessary arrangement to conduct tripartite MOU between Publisher, Agent/Vendor and NML for the supply of MedOne Education Database under NML-ERMED Consortium as per the International Copyright Act.

The EMD/ Security Deposit may be forfeited:

- a. If a bidder withdraws his bid during the period of bid validity specified by NML on the bid form (or)
- b. In case, if the bidder fails to sign the contract, (or)

c. If a bidder seeks change in terms and conditions specified in the tender document or the bid after opening of the bids/tenders and will be treated as Breach of Tender conditions.

**C. Period of validity of bids:-** Bids should be valid for 180 days from the date of their opening by the NML. *A bid valid for a shorter validity period shall be rejected by the NML.* In exceptional cases, the NML may solicit the consent of the bidder to an extension of the period of validity. The request and the responses there to, shall be made in writing (or by fax). A bidder may refuse the request without forfeiting its bid security.

**D. Details of Requirements:** - Supply of MedOne Education Database package offered by the Publishers on order.

**E. Deadline for submission of bids:** - Bids must be received at the address specified above not later than the time and date specified in the invitation for bids.

NML/office of DGHS may use its discretion to extend the deadline for the submission of bids by amending the bidding documents, in which case all rights and obligations of the NML and bidders previously subject to the deadline will thereafter be subject to the deadline as extended.

**F. Late bids:** - Any bid received by the NML after the deadline for submission of bids prescribed by the NML will be rejected and / or returned unopened to the bidder.

**G. Right to accept / reject any or all bids rest with the NML:-** NML/office of DGHS reserves the right to accept or reject any or all bids and to annul the bidding process and reject all bids at any time prior to award of contract or supply order without thereby incurring any liability to the affected bidder or bidders or any obligations to inform the affected bidder or bidders of the grounds for the NML's action.


**H. Placing Order:** -


- Orders will be placed to the successful bidders only when the bidder submits signed terms and conditions based on their quotations and negotiations with them.
- NML/office of DGHS reserves the right to select/alter consortia member institutes (Annexure-I) on administrative / financial grounds.
- The supply orders will be awarded to L-1 vendor(s), (who offered maximum discount) to the maximum extent possible, if the rates quoted by two or more vendors is the same, supply order will be divided equally between different vendors.

I. The bidder is expected to examine all the instructions, form, terms and conditions in the bidding documents. Failure to furnish all the information required as per the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the bidder's risk and may result in the rejection of the bid.

J. The Bidder shall submit an affidavit stating that the bidder has not been black listed by any Government/Quasi-Government institution on Non Judicial stamp paper attested by Public Notary. Annexure-F

**TERMS AND CONDITIONS FOR SUPPLY OF MEDONE EDUCATION DATABASE under  
NML-ERMED CONSORTIUM**

**A. ELIGIBILITY: -**

- (i) The Agent/Vendor should have minimum latest 3 years' experience in supplying e-books/ database /e-journals to Government, Quasi-Government, and State Government and to reputed Indian institutions.
- (ii) Enclose supporting documents—Supply orders from three different institutes and enclose good performance certificate from the same institutes for the year 2020-21, 2021-22 and 2022-23 or latest.
- (iii) The Agent/Vendor should have supplied e-books/database/e-journals minimum costing Rs. 50.00 lakhs to one Institute in each year during last 3 years (2020-21, 2021-22 and 2022-23 or latest).
- (iv) The Agent/Vendor should have minimum annual turnover of Rs. 3.00 crores per year during last 3 years (2020-21, 2021-22 and 2022-23 or latest).
- (v) Enclose a copy of valid PAN card should be in the name of the firm/agency and Enclose copies of ITR for the last three Assessment years from 2021-22, 2022-23 and 2023-24 or latest. (Financial years 2020-21, 2021-22 and 2022-23 or latest).
- (vi) Bidders, who have been disqualified due to their poor performance in the previous year for supply of e-journal, print medical journals, and books at National Medical library need not submit their bids, the bids will not be considered for award of contract for supply of database for ERMED consortium.

**B. For MedOne Education Database:-**

- (1) Access to database of Licensors shall be provided to consortium members on the basis of following options:-
  - a. All the content to all the selected NML-ERMED members as per the supply order.
  - b. Access to NML will be free of charge since it is a Nodal Institute and all the contents covers under the MedOne Education Database will also be accessed at NML and DGHS/MOHFW, Nirman Bhavan, New Delhi.
- (2) Access to members shall be through Internet Protocol (static) IP. In the user institutes where static IP does not exist the licensors shall provide access through login and password.
- (3) The licensors shall provide the NML and licensee the usage statistic report on monthly basis as per the details provided at the Annexure-H and first report must be submitted within Thirty days after award of the contract to vendor. Vendors/Publishers have to develop/provide a mechanism so that statistics of usage by the end users of the member institutes of ERMED Consortium may be opened/printed at NML and the office of DDG, Directorate General of Health Services, M/o of Health & Family Welfare, Nirman Bhavan, New Delhi.
- (4) The new contents added during the contract period shall be provided access at no additional charge.
- (5) The NML shall be treated as the administrative Head Quarter for all the administrative and financial issues related to the supply of MedOne Education Database package from the Publishers.
- (6) Access to all full text contents/database available in electronic form with the Publisher are to be provided.

(7) Training and trouble shooting at site - Publishers and vendors are required to provide adequate number of publicity material brochure, posters, user manual and support material both in print and electronic form for building user awareness.

(8) Publishers and vendors are required to provide support in case of any access problem faced by the member of ERMED. They should have sufficient number of staff to visit sites of ERMED members and solve problem related to electronic access.

(9) Publishers and vendors required to conduct 'Train-the Trainer' Sessions / workshops for library professionals of ERMED member institutes located in different parts of the country without at no extra cost to NML.

(10) Publishers and vendors are required to provide 'Users Training and Awareness' programme to facilitate optimum utilization by the end users.

(11) The ERMED members are required to make their own computer infrastructure arrangement along with the static IP address and adequate internet facility to justify the best use of the expenditure made through the NML-ERMED Consortium. They are expected to arrange audio visual facility, Internet facility, venue and hospitality for training and awareness programme in their own institutes.

(12) Vendors and Suppliers, who agree with the Terms and Conditions specified by NML in the tender document, may submit their Tender.

(13) The publishers/Vendors must agree that in any of the selected products is available to NML/ERMED/Any of its individual member through ONOS or another Consortium, the Publisher/Vendor should refund the proportionate amount to NML. In case, the Publisher/Vendor does not agree on this point, they should not participate in the bid.

#### C. PERMISSIBLE USE:-

1. Allow selected members of NML-ERMED consortium to have access to licensed material from the MedOne Education Database through platform i.e. ermed.in via the secure network of the institutions.
2. All the members have to ensure that they will be using the ERMED resources only for academic purpose and it will not allow any commercial use of the resources for any monetary gain as per the International Copy Right Act applicable to Indian and Foreign journals.

#### D. PAYMENT:-

1. The payment for MedOne Education Database to publishers will be forwarded through selected vendors by NML for Government medical colleges/institutes. No direct payment to publisher for this database is to be made without having permission from NML.
2. Upon submission of Agent's Invoice's along with Remittance proof, Publisher's Price Proof, Agreement, Bank conversion certificate (scheduled commercial bank).
  - a. Initially National Medical Library shall release 90% of the invoice amount and the remaining 10% amount will be withheld and released only after submission of accessibility certificate of MedOne Education Database from the member institutes of Consortium (selected).
  - b. Payment will be made through online mode (NEFT/RGTS, etc.) after deducting TDS/GST as per Government of India rules.
  - c. Multiple year agreement will be invoiced annually and subscription prices should not increase by 2-4 % each year.

(3) The vendors are required to ensure access of all content of database immediately and sign the tripartite MOU (Memorandum of Understanding) between NML, Publisher and Vendor/Supplier. Annexure-G.

(4) In the event the access to license material is stopped from the Licensor's end due to any problem, licensee/subscriber user institute etc. shall be allowed access for the same period/time as the break down, after the term of the contract or licensee/subscriber shall deduct the proportionate amount from the fees payable to the licensor or the licensor shall refund the proportionate amount to the licensee/subscriber.

(5) NML or its implementing agency as licensee/subscriber recognizes that following are obligations on its part.

(6) (a) Maintaining the integrity of the licensed products, and  
(b) Ensuring access to and use of license product is limited to authorized and registered users as defined in the contract.

(7) The licensee/subscriber shall not be responsible for any sales tax, VAT/service tax or other taxes levied by the country of the publisher/vendor or any other license fee or any other hidden cost except the agreed invoiced amount. In case sales tax/VAT/service tax or any other tax is imposed by the country of either party after the date of agreement entered into, the same will be borne by the respective party as of that country.

(8) The agreed terms and conditions can't be altered without mutual consent, in writing of both the parties.

(9) The licensor's liability to licensee/subscriber shall be to a sum equal to the access fee paid by licensee/subscriber, if things go wrong on the part of licensor.

E. **Subscription:-** NML, New Delhi does not bind itself to accept the lowest bid and also reserves the right of rejecting any or all of the tenders without assigning any reason for the same.

The selected Agent/Vendor upon receipt of confirms order shall process institutional subscription and make advance payment to the publisher on behalf of National Medical Library. *The Agent/Supplier shall ensure that the database subscribed by NML for the NML-ERMED consortia members are not to be supplied to ERMED consortia member/partner through any other channel, and to this effect an undertaking by the Agent/Supplier is to be submitted to NML in order to avoid duplication of payment.* The Agent shall submit their list price and per site discount offered within thirty days from date of order along with Remittance proof from publisher, price proof, Bank conversion certificate, Agreement and MOU.

All subscription must be entered in the name of National Medical Library in records of the respective publishers.

For all the database, the Supplier shall charge the Publisher's current subscription rates as indicated in the publisher's current catalogues or invoices. Wherever concessional/Package rates are available/applicable, the Supplier must charge accordingly. The publisher's price proof should support the bills submitted by the Supplier.

Rates quoted for package of database from publisher should include all taxes and mentioned in Indian currency. Original Currency rates by publisher and converted Indian Currency rates shall be provided in the Bid.

The database available in dual foreign currencies should be billed in the currency by which the converted cost is the lowest in Indian rupees.

F. **Subscription period:-** Database is to be subscribed for a period of one year w.e.f. the date of award of supply order.

**G. Conversion Rate:-** The current bank exchange rate (TT selling rate) on the date of remittance shall be used for conversion of foreign currencies supported by a certificate issued by a scheduled commercial bank and countersigned by the supplier. All payments will be made in Indian rupees only through online mode (NEFT/RGTS, etc.) after deducting TDS/GST as per Government of India rules.

**H. Subscription ID's:-** The supplier shall take care to coordinate with the ERMED members to enable online access to all contents of database within one month of signing of the agreement and MOU.

**I. Penalty:-** If the Supplier/Vendor fails to provide access within the time period (One Month) specified in the contract, the Subscriber shall deduct a sum equivalent to 0.5 percent on the proportionate amount of the subscription price for delayed access of database for each week or part thereof up to a maximum of 10% (Ten Percept).

**J. Governing Laws and Jurisdiction:** The contract/license agreement shall be governed by the laws of India and dispute(s) if any arises with respect to/or in connection with the agreement, shall be dealt in the appropriate court of New Delhi, India. Jurisdiction and proceeding shall be carried out in English language.

**K. Tender document and all the Annexures supplied with the tender document is to be filled and supplied with the bid duly signed and stamped otherwise the bid will be disqualified.**

## DEFINITIONS OF TERMS USED IN THE TENDER DOCUMENT

**Licensee, member institutes and Licensor:** NML is designated as "Licensee". The medical colleges and institutions who are members of the ERMED are designated as member institutes. The publishers/vendors are designated as "Licensor".


**Licensed Material:** The content of on-line database of the Licensor/publisher purchased by the licensee (NML) is designated as the licensed material.

**Secure Network:** A network established by licensee and member institutes to access licensed material through authorized identity of IP/password and ID is designated as secure network. The LAN/computer network of authorized member institutes are designated as secure network.

**Authorized users:** List of medical colleges and institutions approved by the competent authority and electronic resources for these institutes are paid through NML are designated as authorized users. They may also be called as registered users.

**Commercial users:** Use of ERMED resources for the purpose of any monetary gain by means of sale, resale, transfer, hire or other form of exploitation of the licensed materials against the International Copy Right Act are designated as commercial users.




